These terms and conditions apply to the purchase of all forms of tickets to The APS PharmSci 2022 Conference, an event organized by The Academy of Pharmaceutical Sciences (APS) (organizer, we, our, us). By purchasing a ticket to The APS PharmSci 2022 Conference you are agreeing to comply with and be bound by these terms and conditions. You should therefore read this document carefully.

The Academy of Pharmaceutical Sciences (APS) reserves the right to change these terms and conditions at any time. Any amended terms and conditions will be posted on this website.

DATA COLLECTION POLICY

The data that is collected through a ticket purchase to The APS PharmSci 2022 Conference and will be used by the Organizer to plan and manage the event for which you registered, as well as email you relevant details about the event. We will not share your data with third parties. If you would like us to remove your data after the Conference, please email your request to info@apsgb.co.uk.

REFUNDS AND TRANSFERABLE TICKETS

Please note that all purchases of tickets to The APS PharmSci 2022 Conference are non-refundable in their entirety after the 14 days cooling off period which begins on the day the ticket payment was received.

Cancellations of your travel and/or hotel reservations are your own responsibility. Please note that if you are unable to attend the conference for any reason you are responsible for cancelling your hotel accommodation and travel.

As we do not refund any tickets after the 14-day cooling off period, we will however give you the opportunity to transfer your ticket to another person. For a transferred ticket to be valid, the change must be communicated to info@apsgb.co.uk before midnight 24th August 2022.

Unused tickets have no monetary value and cannot be credited to future events.

In summary this means:

- The APS PharmSci 2022 Conference tickets are non-refundable after 14 days from the date of payment being received.
- The APS PharmSci 2022 Conference tickets are transferable up until midnight 24th August 2022.



EVENT CANCELLATION AND POSTPONEMENT POLICY

If the organizer cancels the event

As stated in the previous section, purchased tickets are non-refundable. However, in the unlikely event of the organizer's cancellation of The APS PharmSci 2022 Conference, the liability of The Academy of Pharmaceutical Sciences (APS) is limited to the share of paid registration fees that remains after credit card and payment processing fees have been incurred and deducted.

Cancelled event due to fortuitous events

The Academy of Pharmaceutical Sciences (APS) shall assume no liability whatsoever in the circumstances that an event is cancelled, rescheduled or postponed due to a fortuitous event, Act of God, unforeseen occurrence or any other event that renders performance of an event impracticable, illegal or impossible. For purposes of this clause, a fortuitous event shall include, but not be limited to: war, fire, labour strike, extreme weather, pandemic or other emergency.

The Academy of Pharmaceutical Sciences (APS) is not responsible for any loss or damage because of a substitution, alteration, cancellation, or postponement of The Conference.

COVID-19 EVENT AND REFUND POLICY

The Academy of Pharmaceutical Sciences (APS), the organizer, will carry out the event with respect to participants' health and follow current restrictions and regulations from the Public Health Agency of Ireland. (The Public Health Agency (PHA) is the major regional organisation for health protection and health social wellbeing improvement in Northern Ireland).

COVID-19 related refunds

If the organizer postpones the event

If the organizer decides to postpone The APS PharmSci 2022 Conference due to aggravating COVID-19 restrictions, the customer will have the possibility to either keep the ticket to the next APS PharmSci Conference or get a full refund*.

Aggravating covid-19 restrictions includes but are not limited to:

- Limited number of participants allowed at the venue
- National travel restrictions
- State enforced quarantine
- If there is a travel restriction

Up until 1st August 2022, the organizer offers a full refund* to any ticket holder who knows or suspects there will be a travel ban making it impossible for a ticket holder to attend The APS PharmSci 2022 Conference. After 1st August 2022, the ticket will not be refundable due to travel



bans. If a new travel ban is enforced after 1st August 2022, the ticket holder will have the possibility to re-use their ticket at the next event.
